#### Introduction

Welcome to our annual review for 2014-2015, and thank you for your continued support of The Network. This report covers the period from April 2014 to March 2015.

This has continued to be a difficult time for the cultural sector as a whole, and this has been reflected in the membership of the Network. Although 2014-2015 did see some members decide not to renew their subscriptions (a mix of budget pressures and staffing reductions), the majority of members renewed their subscriptions which have enabled libraries, museums, archives, and cultural & heritage organisations across the country to respond to social justice issues and to make a difference to individuals and groups in their communities – please see Appendix B for a reminder about ways of making the most of your subscription.

#### Our work

Key successes included:

- Producing newsletters for April 2014-March 2015
- Producing Ebulletins for April 2014-March 2015
- Regularly adding events, resources and new features to the website<sup>1</sup> which has also been completely re-built (further information about this follows)
- Developing, running and participating in some 7<sup>2</sup> courses and conferences.

Further information about these – and other – areas of work are in the report that follows.

Working towards social justice and developing approaches to community engagement are still very much live issues – in fact, some organisations have even started referring to 'social exclusion' again: it is increasingly clear that libraries, museums, archives and cultural & heritage organisations have a key role to play in this (despite the economic position), and The Network is contributing to the spread of good practice and the raising of our sector profile.

Finally, my thanks to all those who shared good practice, made enquiries, and generally contributed to The Network – please continue doing so!

My particular thanks also go to Nick Little and Oz Osborne at Outsiders Community Consultants CIC for all their help and advice over insurance; and to the team at Electric Putty Ltd for all their advice and support over creating the new website.

## The Network website and statistics

By the beginning of 2014-2015, despite revisions, the website was becoming cluttered and hard to use, and Electric Putty also announced that they had decided to 'decommission' the existing content management system. After some discussions, it was agreed that they would build a new, simpler website, and this was launched in October 2014. It has proved much clearer and easier to use.

There was a period after the new website went live (21 October 2014-3 March 2015, when it was not connected to Google Analytics, so the 2014-2015 figures do not represent a full year.

Here are our 'headline' web statistics:

- 2304 people made 2874 visits (in 2013-2014, 3667 people made 5155 visits)
- Over 65% were from UK, the rest included the US, Brazil, and China
- 76.2% of visitors were new, 23.8% returning

## Making a difference

As noted above, The Network makes a difference, including:

- Drawing together, highlighting and disseminating innovation and good practice (eg information about work with people with dementia and their families; copyright issues in reproducing illustrations)
- Being active in the sector on behalf of members: adding to and widening the debate about libraries, museums, archives, cultural heritage organisations and social justice issues (eg in relation to provision for LGBT people)
- Working with Network members and across the sector to help develop strategy (eg in work with older people)
- Campaigning and lobbying on behalf of the sector
- Giving advice and information, and sharing good practice from other Network members (eg public libraries' work around mental health issues; work with carers; checking what is available in the UK for Disability History Month; libraries and food)
- Giving support to colleagues (eg advice on issues to look at in relation to insurance; finding examples of other organisations that fly the rainbow flag for LGBT History Month, etc; finding speakers for LGBT History Month events; resources to support a member of the public enquiring about gender reassignment)
- Supporting people outside the sector (eg helping independent writers/publishers to get their work seen by the cultural sector)
- Linking the UK cultural sector's social justice work to that abroad (eg in the US, Canada, and Australia).

"John Vincent, co-author of the blog <u>'Social Justice Librarian</u>' and coordinator of <u>'The Network'</u>, recently raised similar concerns about the demise of outreach and targeted services to 'marginalised groups' in <u>a recent piece he</u> wrote on libraries and social justice:

"We know some of the reasons why this is happening: lack of library staff, time and resources; communities overwhelmed by other demands on their time; possibly political views about 'new arrivals'. But is there more to it? Could it be that, surreptitiously, we've become worn down by the calls to return to building-based services, to concentrate on existing users and their demands, to abandon 'risky' types of service, or services that do not show 'high returns' such as increased issue figures and visitor numbers? We do know that the sort of work that is required to make public libraries really relevant is timeintensive, and often involves relatively small numbers of users."

- In October 2014, John Vincent contributed an article, "What about social justice?" to "Leon's Library Blog"<sup>8</sup>
- Also in October, Siobhan Ball, Gulshan Iqbal and John Vincent wrote a blogpost for CILIP, "How to care for sacred texts in public libraries"<sup>9</sup>
- In September 2014, *Not the Information Forum News Briefing* (74)<sup>10</sup> included an article, "We hate no.80: Homophobia" [pp5-7], which reviews John Vincent's book

"John Vincent has demonstrated a lifetime commitment to diversity and inclusion. He has made a significant contribution to raising the profile of diversity and equalities issues in the library and information profession. John has worked in the public sector since the 1960s: for Hertfordshire (where he led pioneering work with a school for young people with severe learning disabilities); Lambeth (coordinating a one-year course for positive action trainees) and Enfield library services. As a children's librarian he worked to develop positive attitudes to equality issues in children's books. In 1997, he was invited to become part of the team that produced the UK's first review of public libraries and social exclusion (from which The Network originated).

John has coordinated The Network since 1999 which works to advocate social justice, to disseminate information and to run courses <a href="http://www.seapn.org.uk/">http://www.seapn.org.uk/</a>. With almost no funding other than small annual subscriptions and income from courses, he has managed to keep The Network at the forefront of diversity and inclusion work in public libraries, museums, archives and the cultural heritage sector.

In 2002, John led a piece of work for the Paul Hamlyn Foundation (PHF) to improve the awareness of library staff on the reading, literacy, and broader 'cultural' needs of looked-after children and young people. John has also worked as part of a cross-England consortium (again part-funded by PHF) to develop public library services for refugees, asylum-seekers and migrant workers, including co-writing the *Welcome to Your Library Good Practice Guide*, in 2007. John also coordinates a number of JISCMAIL discussion lists which help practitioners keep up-to-date with information and developments in the diversity/inclusion area.

John's training work was reassessed by CILIP in 2011, and re-awarded their Seal of Recognition. John has delivered training on Diversity and Equality across all sectors of the profession. He has continued to be active within CILIP, as a member of the Community Diversity and Equality Group committee and part of the judging panel for their high profile "Libraries Change Lives" award.

He has published widely on all areas of equalities, especially LGBT, children/young people, and 'new arrivals' and is widely recognised as an expert in diversity and inclusion. His latest book, published by Ashgate, *LGBT People and the UK Cultural Sector*, examines the complex and conflicting relationships between LGBT people and our cultural and heritage organisations.

John received a Diversity Award from the Community, Diversity and Equality Group in January 2014 in recognition of his "outstanding achievement in the promotion of diversity" and "commitment to the advancement of diversity within a library or information setting".

Libraries in *all* sectors have a crucial role in contributing to social justice which is central to CILIP's Vision of a fair and prosperous society. Additionally, concern for the public good in all professional matters, including respect for diversity within society, and the promoting of equal opportunities and human rights is the heart of CILIP's Ethical Principles."

# Appendix B: Making the most of your subscription

Member organisations and individuals use The Network to:

- Ensure that their services are well placed to meet national, regional and local objectives
- Draw on and share expertise and good practice
- Work with other Network members to benchmark services
- Keep up-to-date effectively with new developments across the social justice field, without having to read every new document themselves as the information has already been distilled for them
- Ensure that colleagues across their service are also able to keep up-to-date via targeted emails to their desk-tops

• Ensure value for money by being able to book places on Network courses and receive in-house training at reduced cost.

When a library (or museum or archive) service from a local authority joins The Network, this automatically confers membership on the **whole local authority**.

The benefits are that:

- Council departments can share knowledge about issues that matter to them, and your service is placed at the centre of this authority-wide information-sharing
- It's a cost-effective way of stretching limited resources (and, in addition, other Council departments could contribute towards the cost of the subscription)
- Related organisations within the local authority area, such as independent and District Council museums, archive collections, schools, and others, can also share this targeted information in an extremely effective way.

Some public library services forward the Newsletter and Ebulletin (as well as other emails from our elists) to targeted contacts across the Council (thereby ensuring that the library service is contributing to corporate targets and agendas), and have also subscribed key local authority staff to some of the elists. Information is also forwarded to contacts in the community.

They also regularly share updates on service developments with other Network contacts, and ask for advice and suggestions on service plans. In one authority, a contribution towards the cost of the annual subscription is received from other Council departments in recognition of the value of this information-sharing.

# Profit & Loss Accounts: April 2014-March 2015

**Note to the accounts**: One of the problems with an annual accounting system is that it does not include funds carried forward from previous years. In fact, The Network came into 2014-2015 with £13,834.40 in the bank, and some of this was used to pay for the website upgrade, together with the remainder of the funds in the WTYL account (£1,282.22) as the work involved checking all the items on the WTYL website and transferring over any that were still 'live'. Therefore, although the 2014-2015 Profit & Loss Accounts show a loss, in fact we still have funds in the bank!
