### Report by the Networker

The Network has really taken off this year! I worked some 1,098 hours for the Network between April-December 2002, broken down approximately as follows:

This is an outline of what that has involved.

A major part of the work has been in developing and delivering the wide range of training courses (listed above).

I have contributed articles to *Public Library Journal* and *Personnel, Training and Education* and have collected most of the content for and written the Newsletters in this period.

I have also attended a number of meetings, including those with: Geraint Hughes (Devon Library Service) to plan the course for them; Mary Anne Edwards (London Museums Agency) to discuss ways in which the LMA and The Network could work together; Diane Chilmaid and Sue Fordham (Kent Arts & Libraries) to discuss the "Words without Frontiers" project and Conference; Sian Harrington (a Museums Studies student) to discuss equalities work; Juliet Owen and Alan Cooper (CILIP) to discuss the updating of the CSG Website and the hosting of The Network's own Website; Mark Norman about the Sexuality Issues in Libraries Group; Charlie Leadbeater (Demos) to discuss the DCMS 2010 Vision; Chris Blowman ("Caring with Books") to discuss services for looked-after children; Rajiv Anand and Marcus Weisen (Resource) to talk about The Network's work and how it could relate to their areas; Bristol Library Service Senior Management Team to report back on the outcomes from their seven courses; Tim Caulton (Consultant) to discuss the way forward for MAGDA and its possible relationship with The Network; Caroline Lang and Rebecca Linley (Resource) about the work The Network is currently undertaking; Anne Harding (Consultant/Trainer) to plan the course for ASCEL; John Pateman (Merton Library & Heritage Service) to discuss The Network's current work.

I was also interviewed on the 'phone by Sarah McNicol (UCE) about research needs in the library and information sector.

In addition, I have carried out all the administration for the Network, including invoicing and banking income; dealing with suppliers' invoices and raising cheques; and answering the growing number of letters and e-mails about the Network's work.

As noted above, the cross-domain work is growing, and, on behalf of the Network, I would like to thank Resource for their financial support for this, for the updating and maintaining of the CSG Website, and for our core work. I would also like to thank the Paul Hamlyn Foundation for their grant to carry out the looked-after children project.
