David Owen notes this important change:

"On 8th September JISC TechDis reported that JISC had announced that TechDis will cease to be hosted by the Higher Education Academy in York from 31st December 2014 which 'means that JISC TechDis will no longer exist as a separate, distinct service providing advice and guidance on technologies to support disabled students and staff.' JISC is restructuring its services to create a centralised operation with a single helpdesk and this is obviously creating uncertainty for the future of the TechDis services and staff at a time when their customers have to address changes to the Disabled Students' Allowance and the new Special Educational Needs and Disability reforms.

I was not aware of these major changes which are not just of interest to colleagues in the academic sector because TechDis services are of value across the disability sector."

This brief exchange from the UK Parliament Questions on Immigration and Asylum is very revealing:

"Philip Davies: How many illegal immigrants have been granted asylum or indefinite leave to remain in the UK since 2010. [905430]

Reply from the Minister for Security and Immigration (James Brokenshire): We grant humanitarian protection only when it is genuinely needed. Sometimes that includes people who have overstayed their permission to be here, or who have entered the country without permission. Since 2010, 18,000 such people have been granted asylum.

Philip Davies: Surely anybody who enters this country illegally should not be able to remain here with indefinite leave or be granted asylum, but should go through the proper processes ..."

"Frank Field [209994] To ask the Secretary of State for the Home Department, with which countries the UK has readmission agreements for the return of nationals found illegally in the UK.

Reply from James Brokenshire: The UK participates in EU readmissions agreements with Albania, Bosnia-Herzegovina, Former Yugoslav Republic of Macedonia, Georgia, Hong Kong, Macau, Moldova, Montenegro, Pakistan, Russia, Serbia, Sri Lanka, Turkey and Ukraine. The UK has bilateral readmission agreements with Algeria, South Korea and Switzerland. The UK has memoranda of understanding for the return of nationals found illegally in the UK with Afghanistan, Angola, Burundi, China, Democratic Republic of Congo, Guinea, Iraq, Kuwait, Malaysia, Nigeria, Rwanda, Sierra Leone, Somaliland, South Sudan and Vietnam."

"A stateless person is someone who has no nationality. They are not Japanese, not Cuban, not Danish, not Ugandan – they do not enjoy the legal bond of nationality with any state. International law defines a stateless person as someone "who is not considered as a national by any state under the operation of its law" (Article 1 of the 1954 Statelessness Convention)." [p1]

Just in case you missed this news announcement on 14 Oct. To summarise the changes:

"A new charity, retaining the name English Heritage, will run the National Heritage Collection of historic properties. A newly-named non-departmental public body, Historic England, will be dedicated to offering expert advice, championing the wider historic environment and providing support for stakeholders in the heritage sector. The changes will come into effect on 1 April 2015. The Minister confirmed that the Government will provide additional funding of £88.5m to invest in the National Heritage Collection."
