A new "report on migrants and refugees' experiences with loneliness in London" from The Forum.

"The Forum, with its Mentoring Project, assists its member to overcome isolation and confront their loneliness. The Forum's experience has shown that:

- Keeping people connected and active in difficult times works well to tackle loneliness.
- Volunteering reduces exclusion, social isolation and loneliness.
- Practical support can affect attitude, since a positive change can have a positive impact on their physical and mental health.
- Isolated people tend to feel lonelier when they are distressed;
   building trust and relationships with others develop mentees' skills to manage stressful situations.
- Attending educational activities is beneficial for mentees' confidence and wellbeing.
- Developing community-based support networks keeps people active within the community.
- Giving people stability enables them to think about their future and maintain connections." [p6]

This ties in well with the experiences that the cultural sector can offer.

Interesting and positive posting from IPPR, in which the authors argue that the discussion around migration needs to be re-shaped so that it is not focusing on tensions between 'citizens' and 'migrants', but between people who feel more or less settled in and committed to their community.

It suggests three key changes:

- 'Coming clean' on the new steady state of immigration
- Increasing the commitment of new migrants
- Helping communities to cope (by pursuing a much more active community policy).

In addition, IPPR have just published **Shared ground:** strategies for living well together in an era of high immigration, which explores how to support migrants and British people to live well together. The authors argue for a more coherent integration strategy in areas characterised by increasing diversity and ongoing, high inflows of immigration. See:

Forecast from the New Local Government Network of what provision could look like in 2020 – a rather depressing vision of reduced services, with communities being encouraged to develop 'commons' ie "those things that we all use but which none of us straightforwardly owns" [p20] via civic action. This in itself is not necessarily a bad thing – provided it doesn't mean that it has to replace existing services.
