Great news for Network members Cumbria:

"An arts project that supports young, disabled and disadvantaged people in the county has been awarded £40,000.

Cumbria County Council secured grant funding from Arts Council of England lottery funding, to support "The Seven Stories", a new project based at Carlisle and Penrith Libraries.

The Seven Stories, 16 month arts project, will target hard-to-reach groups and local schools through a programme of art workshops, exhibitions and performances.

The work will then be exhibited at Carlisle Library in November 2015, with a second exhibition and performance taking place in February 2016."

According to this study, more than 50,000 young people aged 16 to 18, who are neither in education nor work, have gone missing from official statistics and are receiving no support. It argues that tackling the NEET issue doesn't require major new resources or far-reaching changes to national legislation or policy. It does however, require a proper count, at both local and national level, to reflect the true scale of the problem and push the issue up the political agenda.
