"Welsh cultural inclusion scheme gets £125,000 boost"

"The Welsh government has awarded an additional £125,000 to the Fusion: Tackling Poverty through Culture programme.

The funding boost was announced by the economy secretary Ken Skates last week during a visit to Amgueddfa Genedlaethol y Glannau (the National Waterfront Museum, Swansea), which is running a Fusion project for young people.

Launched in 2015, the scheme offers people from disadvantaged areas new opportunities to engage with culture and heritage, while at the same time encouraging cultural bodies to increase the impact they have on the lives of individuals and communities.

The extra money will enable Fusion to expand its reach, increasing the number of Pioneer Areas that receive targeted funding from six to 10. The four new Pioneer Areas are Flintshire, Caerphilly, Conwy and Carmarthenshire."

"The Home Office and Department for Education have today (1 July) launched a new voluntary transfer arrangement between local authorities for the care of unaccompanied children who arrive in the UK and claim asylum. The National Transfer Scheme has been launched to encourage all local authorities to volunteer to support unaccompanied asylum-seeking children (UASC) so there is a more even distribution of caring responsibilities across the country.

Under the scheme, a child arriving in one local authority area already under strain caring for unaccompanied asylum seeking children may be transferred to another council with capacity."

> "Around a quarter of a million Latin Americans live in the UK, with over half (145,000) in London. The Latin American population is one of the fastest growing migrant populations in London, with two-thirds having arrived since 2000. Official monitoring data on this group is sparse, limiting the ability of policymakers to plan appropriate services and make

targeted policy interventions. The QMU research sheds new light on the population and offers policy recommendations.

Brazilians are the largest national group, making up over a third of the Latin American population in London, followed by Colombians (around a fifth). The next largest groups are from Ecuador, Argentina, Venezuela and Mexico. The proportions are similar in the rest of the UK.

Of those living in the capital, more than two-thirds are in Inner London, with particularly large concentrations in Lambeth and Southwark, followed by Brent, Westminster, Wandsworth and Haringey." In June, Pride in London, in partnership with Quadrangle and Populus, conducted a survey of more than 1000 LGBT+ people in the UK.

Headlines include that 75% of LGBT+ people still feel the need to lie about their sexuality or gender identity; are six times less likely to hold a partner's hand in

public than the rest of the population; and that LGBT+ respondents are five times more likely to have been bullied at work because of their gender.

"The Museums Association (MA) is launching a Museum Taskforce, comprising museum leaders from across the UK, to look at the challenges and opportunities that museums face in the short to medium term.

The taskforce will focus on museums that are not in receipt of national funding as the principle source of their revenue in England, Scotland, Wales and Northern Ireland.

It will examine the impact of Brexit on the museum sector and consider responses to the increasingly difficult financial situation that many museums in the UK face.

The taskforce will produce a state of the nation report on museums in the UK, and share potential routes to sustainability, looking at all possible options.

And it will use research and evidence to advocate on behalf of museums to funders, politicians, stakeholders and the public, providing a unique and independent voice to stand up for museums across the UK."
