Important blogpost in the School Library Association's "Discussion and Development Blog" series – this one looks at how poverty can affect young people at school, and suggests ways in which school libraries can provide support to children and families on low incomes, including providing access to ICT, especially at lunchtime and after school; longer opening hours; providing homework clubs and supported-study sessions; lending resources and equipment - but to all students, not just those deemed to be 'in need'.

"National reading charity, The Reader, is working with Suffolk Libraries to launch a new kind of Shared Reading community in Suffolk. Through reading aloud together, the charity hopes to transform rehabilitation for local people leaving prison, improve their wellbeing and build a community.

Funded by Suffolk Police and Crime Commissioner (PCC), the year-long 'through the gate' pilot will see six volunteers trained to lead new Shared Reading groups in three Suffolk Libraries, with 30 local people benefitting from reading aloud together each week."

Interesting article that looks at engaging with and learning from young people – it starts with a project in Cumbria:

"In West Cumbria in the north of England, for example, local authorities are working together on the Connected Communities[*] project, which aims to enhance the community's well-being, sense of citizenship and capacity to make a difference.

In this project, children from communities experiencing significant hardship conducted their own community research, exploring local people's social networks, feelings of loneliness and emotional well-being. As the project progressed, the children's mental well-being improved through the process of having their voices heard — especially by those in positions of power locally."

*"Since 2010 the RSA and its partners at the University of Central Lancashire (UCLan) and the London School of Economics (LSE) have been working with communities in seven locations in England to research and strengthen relationships within communities.

The vision of 'Connected Communities' is one in which people are embedded within local networks of social support; in which social isolation is reduced and people experience greater wellbeing and other benefits from the better understanding, mobilisation and growth of 'community capital' in their neighbourhoods." "This report outlines learning and reflections from the Engaging Libraries programme, a partnership programme between the Carnegie UK Trust and the Wellcome Trust [...]

Engaging Libraries was a pilot programme, aimed at giving public libraries in the UK and Ireland the opportunity to test out creative public engagement projects on health and wellbeing. It did so through providing project funding and by encouraging and facilitating participating libraries to engage with one another while developing and delivering their projects. Engaging Libraries worked with 16 public library services over the course of a year to deliver 14 projects. These projects were delivered by library services in collaboration with a wide range of partners." [p3]

"This report seeks to highlight the innovative work of the Engaging Libraries projects and set out the key learnings and reflections from the programme to help support future, high quality public engagement practice." [p5]

Day in June by Gayle E. Pitman and Two Boys Kissing by David Levithan—were also both burned by a religious activist to protest a Pride event, according to the ALA OIF.
