Press release announcing that:

- "Over £25 million of funding to be allocated to over 100 areas across England – including 20 new rough sleeping centres
- Funding to provide specialist support for the most vulnerable rough sleepers including those with mental health or substance misuse issues"

Provision will include:

- 20 new "Somewhere Safe to Stay" rough sleeping centres where people on the streets can access professional help and guidance, including immediate shelter and mental health support
- Over 130 navigator posts specialist support workers who direct people to the services they need, such as counselling, housing advice, mental health support or substance misuse services
- 61 supported lettings schemes helping people to secure tenancies in properties that they may not otherwise be able to access
- 30 dedicated local letting agencies specialist agencies that support vulnerable people into affordable and stable accommodation"

"A digital health hub piloted in Nailsea has proved to be such a success that the NHS is scaling it up across England [...]

The project is a partnership between local NHS services, Nailsea Town Council and Healthwatch and is supported by local volunteers, including local students, who provide one to one support. It has also seen support from local organisations to national charities, who have run group meetings or hosted private sessions for the people of Nailsea.

Organisations in five new areas will now use their own digital health hubs to learn what works in their area. Using the learnings from existing Pathfinders, including Nailsea, they'll will be making sure the most excluded in their boroughs have the chance to benefit from digital. This second wave of hubs will be in Blackburn with Darwen Library, Staffordshire Refugee Centre (ASHA), a community centre in Saltburn and the Grenfell victims support centre in NW London."

Fascinating article that looks at the growing populist voice, and suggests:

"The question is understandable and legitimate. It is also largely misleading. The current explosion of incivility in everyday life and hostility to international liberal principles may illustrate striking similarities to the political and social milieu of the interwar years. But this does not mean that it is fascism 2.0, nor is it the main problem we should be worrying about."

The article goes on to argue for the need to continue vigilance and fighting for human rights:

"The successes of contemporary populists should remind everyone that fascism may have been crushed in 1945, as postwar societies have so often been told ever since; yet the political, social, and cultural forces that sustained it in the first place never went away. This is perhaps the most useful "lesson" from history – that there are no final victories – or defeats."
