It takes a system: the systemic nature of racism and pathways to systems change

Important new report:

"It is now normal to hear that racism is systemic. This is an important and essential truth and one worth holding on to. In a time of COVID-19 and Black Lives Matter, systemic racism, as a term at least, is on the agenda.

But what does systemic racism really mean?

The problem with the concept of systemic racism as it stands now is that it obscures as much as it reveals. A lack of clarity on what systemic racism is and how it works risks it becoming an almost mystical concept – one which is too easy for cynics to dismiss. What is more, research shows that racism is viewed mostly as personal prejudice [...] and hostile actions directed by one person towards another, rather than as something that is designed into our systems.

With this as the state of play, how can we move decisively away from systemic racism towards systemic racial justice?" [p5]

The MA has produced this Manifesto as part of its campaigning role.

It highlights the positive role that museums play ("Making Scotland a better place to live, work and visit"); and then raises key issues for the next Scottish Government:

- Securing the future
- Supporting partnerships
- Representation for all
- Access for all.

Under "Representation for all", it includes:

- "Museums should be supported to be inclusive, participatory and democratic spaces where people from all backgrounds feel welcome and represented as visitors, contributors and in the workforce and at board level.
- Museums should be supported to decolonise their practice and collections, building on the substantial, sector-leading work that is already happening in Scotland. Museums across Scotland should work to increase research and public engagement to recognise and come to terms with Scotland's colonial past, legacy of slavery and racism."

"This 96-page Guide sets out what human rights are, the main human rights Conventions and Declarations that relate to museums, and particular rights especially relevant to museums. The Guide goes through a human rights-based approach applied to museums, which is a planning method to help more people attain their basic rights through museums, and for museums to provide more effective, transparent and transformative public service.

It is especially important that museums, and those who fund them, reflect on how they are supporting people's rights, in a climate of competition for funding. The Scotland-wide "New Scots Integration: Rights & Communities" programme ran from 2018-2020 and

"[...] supported 1190 New Scots to achieve their ambitions for work, education and community life; and 189 organisations across Scotland to build their capacity to welcome and support the integration of New Scots." [p3]

Drawn from this, the Scottish Refugee Council has produced three toolkits – this is the first:

"This toolkit is for public authorities (local, regional and/or national) and/or civil society organisations creating or developing direct services to newly-recognised refugees: physical or remote holistic advice and advocacy services/one-stop shops; and language and employment services.

- 1. Supporting refugees to create their own Holistic Integration Plans
- 2. Individual employment action plans for refugees
- 3. 'Survival English' Language Programme
- 4. Widening information and advice access to asylum seekers and refugees digitally" [p2]
