### The transatlantic slave economy and England's built environment: a research audit

Major new report from Historic England:

"This is a summary report of a desk-based review of existing research into connections between the transatlantic slavery economy and England's built environment. It also identifies gaps and recommends areas for future work in this area. Interspersed throughout this report are references to published literature, to the responses of heritage groups, organisations, and artists. These research outputs are listed fully and categorised, with many others, in the accompanying bibliographical Excel database. The time allotted did not allow for new research into slaving wealth and how it was spent in England." [p1]

"Art institutions are facing a reckoning over colonial histories and racist legacies [...]

Many of these projects include investigations into how items in museum collections were acquired and how they are interpreted and displayed. In some cases, this involves reviewing the processes of returning looted artefacts from the colonial era.

Contemporary art galleries, however, appear to be absent from these discussions and actions. My research aims to tackle racism within English public contemporary art galleries. As part of it, I asked artists, curators and gallery workers to share their experiences with me for #GallerySoWhite, a digital exhibition highlighting people's experiences of institutional racism in English contemporary art galleries. What I found was alarming."

### Ethnic inequalities in COVID-19 mortality: a consequence of persistent racism

New briefing from the Runnymede Trust. Key points are:

- "Ethnic minority people experience a much higher risk of COVID-19related death, a stark inequality that impacts on all ethnic minority groups, including white minority groups such as Gypsies and Irish Travellers.
- Local authorities with higher proportions of ethnic minority residents are likely to have higher numbers of COVID-19-related deaths.
- These inequalities reflect increased risk of exposure to the virus because
  of where people live, the type of accommodation they live in, household
  size, the types of jobs they do and the means of transport they use to get
  to work.
- Ethnic inequalities in relation to COVID-19 mirror longstanding ethnic inequalities in health. A large body of evidence has shown that these
- inequalities are driven by social and economic inequalities, many of which are the result of racial discrimination.
- Ethnic minorities are also at increased risk of complications and mortality post COVID-19 infection; greater risk of serious illness with COVID-19 is more likely the result of pre-existing social and economic inequalities manifesting in the form of particular chronic illnesses. There is no evidence for genetic or genetically related biological factors underlying this increased risk, including vitamin D deficiency.
- Unless racism is understood as a key driver of the inequalities which increase the chances of exposure to and mortality from COVID-19, government and public sector policy responses to the coronavirus pandemic risk further increasing ethnic inequalities in the UK." [p1]

"As part of our continued response to the coronavirus (COVID-19) crisis, we are reopening our National Lottery Grants for Heritage to support organisations working with heritage to adapt and respond to the changing environment they are now operating in.

The reopening is happening in two phases [...]

#### Phase 2

Beginning 8 February 2021, we will resume accepting applications for grants from £100,000 to £250,000 and £250,000 to £5m. From February 2021, we will prioritise heritage projects that will:

- boost the local economy
- encourage skills development and job creation
- support wellbeing
- create better places to live, work and visit
- improve the resilience of organisations working in heritage

We will also expect all projects to demonstrate that they are building long-term environmental sustainability and inclusion into their plans, as appropriate.

New application and good practice guidance will be available on 8 February."
