The article also includes a statement from the MA:

"The Museums Association supports the International Council of Museums' condemnation of the invasion of Ukraine by Russian Federation military forces and echoes its concern about the risks faced by museum professionals on the ground in Ukraine.

Already the international museum community is rallying and offering support, including refuge, and we encourage colleagues in neighbouring

countries in particular to continue and step up their offers of solidarity and support.

Many museum workers in Ukraine have previously been involved in human rights movements and many museums provide space for the promotion and discussion of human rights. This puts museum workers at particular risk in the current situation.

The primary concern must be the safety of museum staff and the wider population – in addition there is a threat to the material cultural heritage of Ukraine and, as signatories of the 1954 Hague Convention for the Protection of Cultural Property, in the event of armed conflict we would call on both countries to abide by their international legal obligations to protect heritage."

"Historic England is inviting applications from community or heritage organisations to apply for grants up to £25,000 to fund projects that will celebrate the built or historic environment near them. We are particularly interested in funding smaller grass roots projects of less than £10,000.

Each project should enable people to creatively share overlooked or untold stories of the places where they live and encourage communities, groups and local people to examine and tell their own stories in their own ways.

Historic England is also hoping for projects that provide innovative volunteering opportunities for young people or people facing loneliness or isolation, as well as contribute positively to participants' wellbeing.

As a result of these projects, heritage and stories that have been previously overlooked will be recognised and revealed, with buildings or historic sites acting as the inspiration. People will be able to tell their own stories, in their own way, and be encouraged to connect with others in their local communities."

The closing date for submission of proposals is **Monday 23 May**.

Research digest: young people's mental health

"We included peer-reviewed, primary research that was published in English between 2011 and 2021. We looked for research where the focus of the research was on teenagers and young adults (11-25 years) and explored the value of culture in relation to wellbeing or mental health." [p5]

## Key findings included:

"Overall, the qualitative data paints a very positive picture for the value of arts and culture, specifically music, in supporting the mental health and wellbeing of young people. In particular, the research highlights the role of arts and cultural experiences in helping young people to build their confidence and self-esteem (observed in 60 per cent of studies). Although the mechanisms for these factors were not explicitly explored within studies, being able to perform or showcase artwork, compose

music and devise theatre productions led to young people feeling a sense of pride and achievement through the positive feedback they received.

A number of studies (50 per cent) referenced the idea that cultural experiences provided a 'safe space' for younger people: a space which was referred to as 'non-judgemental', a place for positive social experiences and an opportunity for escapism. Young people also developed strong relationships with cultural practitioners who showed empathy and understanding towards the challenges they faced. There were groups of young people who could be considered to be 'vulnerable' within the research we looked at, so this is an important element to be explored in future research." [p9]

The key issues identified include:

- The effects of the pandemic
- Fears for future work
- Relationships at risk: "The happiness young people feel in their relationships with both friends and family have dropped to the lowest levels on record, with many young people reporting feeling lonely as well as nervous about socialising." [p8]
- Pressures on young women.
