"Sutton Council libraries will be used as Warm Spaces for residents who may be struggling to keep warm at home in light of rising energy bills.

Launching in October, Sutton's Warm Spaces will provide a warm welcome for all, and information about cost of living support will be available for those who need it.

Residents are welcome to stay in the library for as long as they want to during opening hours, and will have access to wi-fi, computers and assistance with using them if they need it.

At four of Sutton's Libraries – Sutton Central, Phoenix Centre, Sutton Life Centre and the Circle Library – trained Warm Spaces Volunteers will be on hand at specific times for a chat and to help direct residents to resources and organisations that can help them with the cost of living."

"As winter approaches, many museums and galleries are considering what they can do to help those who are bearing the brunt of the cost of living crisis.

Some institutions are joining networks of warm havens, which are being established in parts of the UK to offer free and welcoming public spaces to those who cannot afford to heat their homes.

Cultural institutions are increasingly working with local health and social care providers to deliver initiatives to support health and wellbeing. There are a growing number of opportunities for museums to get involved, including schemes like Buildings at the Heart of the Community, which was launched last year by Community Health Partnerships to give charities and community groups free use of buildings in the NHS estate for outreach activities that support health and wellbeing.

Eleanor Root, the collections and learning curator at Colchester & Ipswich Museums, recently launched an open Google document where museums can share advice on how to support people, and is encouraging others to contribute their ideas."

"Our Good Childhood Report 2022 shows that children's happiness continues to decline. Young people are on average less happy with their life as a whole, school, friends and how they look than ten years ago."

#### Key findings include:

- "UK children's happiness with their lives continues to decline.
- More children are unhappy with their appearance than with family, friends, school and schoolwork. Girls are more likely to feel this way than boys.
- Happiness with school and schoolwork declines significantly with age, and was significantly lower among children in lower income households.
- Over half of parents and carers feel that the pandemic has had a negative impact on the education of their children.
- 85% of parents and carers are concerned about the impact of the cost of living crisis on their household/family over the next 12 months, which will only get worse as this crisis unfolds." [Taken from web version]

"A key way to encourage deaf, disabled and neurodivergent visitors to your heritage site is to improve the pre-visit access information available online. Between May and August, over 50 volunteers checked the access information on over 2,000 heritage sites, as part of the Heritage Access 2022 project, made possible with public funding from the National Lottery Heritage Fund. Together with project partners Stagetext, Centre for Accessible Environments and Autism in Museums, we're now in the

process of pulling together the data from that research and writing a report to be published in late October."

"Albania may or may not be "safe and prosperous" for many of its citizens. That is not the point; on current statistics, the majority of the Albanians fleeing their country to claim asylum in the United Kingdom are victims of trafficking and are recognised by the Home Office as such. It takes time to assess whether a person is a trafficking survivor. A rapid

returns deal places vulnerable and exploited people at risk of further harm."
