New from JCWI is this comic-book-style guide to starting to dismantle the hostile environment:

"Sometimes, the things we fight against can seem all-powerful. But the solutions here are simple: recognise the work of all migrants, dismantle the Hostile Environment and make sure everyone who is living here can access the public safety net." [p5]

New report from Speech and Language UK, which says that:

"Teachers now estimate 1.9 million children [...] are behind with their talking and/or understanding of words – the highest number ever recorded." [p3]

As they go on to emphasise:

"Children who struggle to talk and understand words are:

- six times more likely to fail English tests at age 11,
- eleven times less likely to pass maths,
- twice as likely to have a mental health problem, and
- twice as likely to be unemployed as an adult." [p3]

The report concludes with 9 recommendations for improving speech and language support for all children and their families.

Brief critique of the existing Test:

"My research has exposed serious failings in all test editions. These include that some of the test's "correct" answers are factually incorrect; that key practical information, like how to report a crime or register with a GP, is missing, while impractical trivia like knowing the height of the London Eye or how the founder of the first curry house married his wife means that the test is politically partisan and gender imbalanced [...]

It is the only citizenship test in the world that does not require anyone to know who the head of state is, how many elected legislators there are in Parliament, or what is the law court with the highest jurisdiction. Yet, all new citizens must swear allegiance to the head of state." [p1]

The latest report from NLT has just been published. Key findings include:

- "Just 2 in 5 (43.4%) children and young people aged 8 to 18 said they enjoyed reading in their free time in 2023. This is the lowest level since we first asked the question in 2005."
- "There has been a 26% decrease in the number of children and young people aged 8 to 18 who read daily in their free time since 2005 (decreasing from 38.1% to 28.0%)."

The Key Findings webpage concludes:

"Declining reading enjoyment across a growing number of children and young people must act as a wake-up call for all who support children and young people's reading for pleasure and the many benefits it can bring."
