# Global report on children with developmental disabilities: from the margins to the mainstream

"Using findings from research and practice and guided by the tenets of international human rights conventions, this WHO-UNICEF *Global Report on children with developmental disabilities* provides principles and approaches to intentionally include the needs and aspirations of children and young people with developmental disabilities in policy, programming and public health monitoring. It makes the case for greater accountability and proposes 10 priority actions to accelerate changes towards inclusive environments and responsive multisectoral care systems for children with developmental disabilities." [website]

Amongst the report's recommendations are:

- "promoting a culture in which diversity, inclusion and respect are valued, social connectedness is promoted and hostile and/or discriminatory behaviour is not accepted;
- adopting and supporting communication strategies to promote the expression and comprehension of children with various speech, language and communication abilities and preferences;
- monitoring and managing the physical and sensory environment to facilitate participation;
- promoting access to health information in formats that are accessible to children and young people with developmental delays and disabilities, and to caregivers with various levels of literacy;
- promoting access to education and opportunities for learning across the life-course, with allocation of adequate financial and human resources;

- promoting access to a range of assistance, assistive devices and support services for children and caregivers, and supporting transitions to independent living for young people with developmental disabilities; and
- enhancing or redesigning the development of human resource capacity to ensure competent care and positive attitudes in health-care workers and other professionals." [p87]

"Braverman faced a backlash after The Times leaked details ahead of a speech she delivered in Washington DC on Tuesday (26 September), in which she argued that a fear of discrimination should not be a good enough reason to be granted asylum in the UK."

A statement from the Elton John Aids Foundation said:

"Nearly a third of all nations class LGBTQ+ people as criminals, and homosexuality is still punishable by death in 11 countries. Dismissing the very real danger LGBTQ+ communities face risks further legitimising hate and violence against them."

Useful reminder:

- "The most common main languages, other than English (English or Welsh in Wales), were: Polish (1.1%, 612,000), Romanian (0.8%, 472,000), Panjabi (0.5%, 291,000), and Urdu (0.5%, 270,000).
- The largest increase was for people who specified Romanian as a main language, who accounted for over 0.8% of usual residents in 2021 (472,000 people), up from 0.1% (68,000) in 2011."

There is also a useful listing of "The top ten main languages spoken in England and Wales, excluding English (English or Welsh in Wales)".

Shocking article, exposing the terrible conditions in one centre:

"[...] the 55 residents housed in this processing centre run by a private company have severe or life-limiting disabilities. Some have lost limbs, others are deaf or blind. Half a dozen are paraplegic. Some have been disabled since birth; others were maimed in the war zones they're now fleeing from.

Ask an official, and they'll likely describe the site as a "former care home", but you'd be hard-pressed to find much care. There are no grab rails in the property. No changing beds for incontinent residents or commodes for those who can't make it to the toilet. Bathrooms don't have shower chairs to enable people to wash."

Important new report:

"People fleeing war and persecution have a right under international law to seek asylum, but currently face life-threatening journeys to safety in the UK. With travel options blocked, refugees are forced into the hands of ruthless smugglers who exploit the UK's lack of safe passage, cramming men, women and children into dangerous small boats to cross the Channel." The report recommends three priorities:

- 1. "Ruin smugglers deadly trade by establishing safe routes for those seeking safety in the UK.
- 2. Renew Britain's commitment to international cooperation.
- 3. Restore the right to seek asylum and rebuild our asylum system."
