The latest Index has just been published:

"Improvements in digital skills have been made over the last three years for those with an impairment vs. those without, yet the Essential Digital Skills data shows there is still a gap. Exploring this group further, it's those with a physical impairment that are least likely to be able to complete the fundamental tasks to engage with a digital world.

Accessible services, connectivity and complexity remain challenges for those who are not engaging digitally, e.g. 13% of consumers report connectivity issues, which affects their Internet usage, and 16% think the Internet is too complicated." [p4]

As Good Things Foundation's Helen Milner writes in a blogpost (https://www.goodthingsfoundation.org/discover/digital-inclusion-insights/digital-inclusion-insights-2024/power-up-2-index-employment-link):

"There are still nearly 8 million adults who lack the digital basics (foundation level). Most (but not all) are older, living alone, have no formal qualifications, and/or live with a long-term health condition or disability.

Looking only at the working-age population, around 18% (c7.3m) lack the digital basics most needed in the workplace, with 6% (2.3m) able to do

none of the tasks. In a digital economy, just under half of working-age adults can do all 20 tasks.

If this sounds depressing - it is. But there is also a strong and positive call to collective action in this year's UK Consumer Digital Index. Over 22 million people would like to improve their digital skills. We can and must respond to this, and do so in ways that work for diverse communities, and especially for those who lack the confidence to learn - often shaped by poor past experiences of learning - and for whom this is a barrier to finding pathways into economic participation."

"The socially restrictive lockdown measures appear to have had a substantial negative effect on the mental health of teenagers, especially girls, and the new study provides a potential underlying cause.

There is little doubt that the pandemic lockdowns resulted in devastating health consequences for many people. To the litany of evidence, we may now add a particularly grim finding – that the developmental brain biology of our precious teenage population has been damaged by these measures.

But perhaps the main message is that the wider effects of single-issue health policies should be considered more carefully. In the case of the known damaging effects of social isolation and loneliness on brain health, it's not as if the evidence wasn't there."

Useful commentary on the latest figures.

The "Notes for editors" that follow the post are very useful for clarifying what's going on:

- "Revisions to the migration statistics have substantially changed the
  official picture on net migration over the past two years. For example, net
  migration for calendar year 2022 was originally estimated at 606,000 in
  the ONS May 2023 publication. It was revised up to 745,000 in
  November 2023, and up to 764,000 in May 2024. Today's release makes
  a third revision that the figure for 2022 at 873,000.
- Revisions have taken place for several reasons. Early estimates make assumptions about which migrants will remain in the UK long term, and these are later replaced with complete travel data. In 2022 and 2023, migration patterns changed with a higher share of visa holders staying in the UK long term, compared to what ONS had expected based on previous data.
- ONS has also made various methodological changes. For example, ONS now has access to more detailed data on people who switch visas incountry (e.g. from a student to work visa). Today's release also includes

a larger number of Ukrainians in 2022 and 2023, who had been missed in earlier releases."

This concludes:

"We can only speculate about whether the government would have made different policy decisions (or made the same ones sooner) if it had had access to accurate figures earlier.

Even if revisions are planned, they may still have a cost: lower public trust in the data.

Of course, ONS could have decided not to publish the data at all, given that the methods were still in development. That is what they have done in other cases, such as the now discontinued estimates of the number of foreign-born people living in the UK. This too has a cost. We can still learn a lot from imperfect data.

Indeed, while the magnitude of the net migration figures has changed, the basic picture has not changed — that unusually high migration has been driven by work and study migration, with more international students remaining long-term in the UK than in the past.

Perhaps ONS should have spotted some of the issues that have led to the biggest revisions sooner. Perhaps they could have advertised more prominently that the data are uncertain and may be revised substantially. Nonetheless, we are still in a much better place than we were before the new methods were developed, even if it has taken some time to get there."

Important article which argues that there are key reasons why human smuggling continues and suggest two other areas which should be explored instead:

"It's peculiar how difficult it is for mainstream politicians, who are otherwise so keen on market economics, to learn that human smuggling is a market driven by demand. It responds to incentives, and its strongest incentive by far is the disappearance of legal routes. The market is further buoyed by crackdowns of the kind seen around the Channel Tunnel in recent years. The displacement of routes has predictably increased danger and desperation – and thus reliance on professional smugglers. The border security system perversely feeds on the very problem it ostensibly combats."

Following on from the publication of the NLT annual literacy survey:

"Many literacy researchers like me are just not surprised by this data. Given the lack of funding and closure of our local libraries. Not to mention the narrow approach to the curriculum for reading in schools, which is targeted specifically at struggling readers. This includes the systematic synthetic phonics (SSP) scheme, which teach children to read by breaking words down into their individual sounds and is pushed too early. As well as the dreaded phonics screening check, which tests your child's phonics knowledge, standardising testing [...]

The joy of reading, alongside the awe and wonder from engaging in meaningful reading activities is slowly being taken away from our children in schools with overcrowded timetables and an overreliance on reading books matched to systematic synthetic phonics schemes. In addition, it now appears that reading at home seems to have become a luxury we can't afford."

The article then goes on to suggest ways of interesting children in reading, eg:

"At home, parents, carers and families can support their children with reading through a range of tactics. Again, diversifying what you read with your children could help. Try reading online or branch out into magazines, comics, leaflets and information books.

If you want to make reading more active why not try taking photographs and making your own photograph books together. You could also play rhyming games. Or, you could simply spend time sharing stories with each other and telling stories as well as reading stories (in print and online)."
