"A new paper has found that social capital 'is the cake, not the icing' of a strong, well functioning economy"

### The article reports that:

"In areas where a big industrial employer has shut down, followed by a period of neglect and underinvestment, [the paper's author] says social capital tends to be weakened over time in a way that exacerbates the impact on the economy.

'It's the things that make places, really: those parks, those youth clubs, those sports facilities, those libraries and museums. And in a sense, social capital has been depleted as a result of the economic shocks, but then has provided its own amplifier,' he says.

'A community that is socially divisive and mistrustful has no hope, whatever you throw at it by way of money, jobs, businesses, infrastructure: basically, you are building them on shifting societal sands.'

It should go without saying that there are already good, solid, Labour reasons for funding youth centres, parks and libraries. Sure Start centres, too."

"Every day in public libraries across San Francisco, patrons find their way to a discreet shelf and pick up titles including Alcoholics Anonymous' (AA) *Big Book*, *Narcotics Anonymous*, and *The Zen of Recovery* by Mel Ash.

Then, without checking out these titles, these patrons leave. They may mark up the books they take. They won't return the materials. And, according to Doreen Horstin, manager of San Francisco Public Library's (SFPL) Park branch, this is just fine.

These patrons are participants in Read to Recovery, an SFPL program that has been providing free addiction recovery materials since spring 2023. The initiative is a way to quietly get thousands of books into the hands of people who need them, ensuring that barriers such as a lack of a library card or hold times don't get in the way."

Just in case you missed this article from the Chief Executive of the Refugee Council, which makes some very important points:

"It is, of course, vital that the public has trust in the government to run an orderly and controlled asylum and immigration system. But melodramatic footage and maligning narratives that risk punching down on the men, women and children in the boats who are victims of traffickers and smugglers will not give the public confidence that the system is working.

To gain that confidence, the most important thing is to clear the asylum backlog and actually fix the asylum accommodation system. The use of hotels in communities across the country has become the most damaging symbol of government failure and a flashpoint for community tensions. Billions are being wasted on appallingly run contracts with private companies that cream off vast profits. Yet there is no serious plan emerging from the Home Office to trigger the contract break clauses due next year and radically reform the system.

The urgency being given to removals should be focused on proposals to quickly transform asylum housing and support.

And let's not forget, it was only in August that mobs seemingly stirred up by the social media antics of the far-right criminal Tommy Robinson sought to burn refugees alive in a hotel. Communities are still healing from that appalling violence. The government must not increase mistrust with performative tactics that play into negative and dangerous stereotypes."

Briefing from MRN:

"The key difference with the Border Security Bill is that for the first time, the counter-terror framework is being used as the primary approach to migration policy. What this means is that excessive powers are able to be brought in with regard to surveillance, pre-crime policing and sentencing. This use of manufacturing a crisis to bring in such legislation mirrors what has happened to Muslim communities with counter-terror powers time and time again. Many of the Border Security Command's functions have therefore been enabled without any scrutiny; the Border Security Bill exists in part to strengthen and expand these capabilities.

A counter-terror approach also enables the Government to bring in powers that would otherwise be seen as excessive and extreme. Overall, the Bill is intended to target intermediaries, who act as agents or brokers to facilitate the travel of undocumented people, including across the Channel in small boats."

"In August 2024, we received funding from Public Voices in AI Fund to investigate the potential role and impact of AI on people seeking asylum in London and the South of England. Through workshops and interviews, we set out to inform and be informed by people seeking asylum about AI through creative activities and gather evidence of its impact on their daily lives."

## Findings include:

- "The widespread prevalence of errors relating to names, date of birth or inaccuracies in asylum interview transcripts."
- "Concerns were consistently raised around the limitations of AI in its ability to understand human behaviour and emotions"
- "Some of the participants stated they had concerns about how AI would impact disabled people, specifically neurodivergent people
- Participants stated they were cautious of AI due to the lack of transparency around how it would be used, and what datasets it would rely on."

This research is available in English, Arabic, Pashto, Farsi and Dari.

"In the 2024 Reception cohort, teachers report over a third (36%) of children struggle to play / share with other children, 34% don't know how to listen or respond to simple instruction, and a quarter (25%) are not toilet trained." [p3]
