Grants will enable the development and continuation of groundbreaking health and wellbeing programmes in UK museums during a time of financial crisis and increasing demand for services.

For the first round of funding, the fund will open for applications on 28 April with a deadline for final submissions by 26 June 2025. There will be a second round in 2026.

Interesting exploration of the reasons for the growth in the number of young people who are Neet and what can be done about it:

"The government is concerned about the rising number of young people aged 16 to 24 who are Neet, which in the quarter to December 2024 was estimated at 987,000 in the UK. This is 13.4% of all young people in this age group. The increase, from around 11% in the period prior to the start of the pandemic, is linked to long-term illness among the economically inactive [...]

The government's programme for change is evidence-based and they are to be commended in recognising and beginning to tackle long-standing issues of Neet among young people. The announcements on welfare will help, but we still need to tackle the root causes of high Neet rates in the UK.

Youth transitions need to be better managed by all agencies of government, especially for those who have mental health challenges. There also need to be better jobs available for young people who become disillusioned with the education system.

Growing the economy, together with the package of measures announced, will go some way to help. But some support needs to start even earlier. Young people who do not perform well in school have few education or employment options – this is the real tragedy of lost generations."

LGA case study:

"Buckinghamshire Archives worked with the National Paralympic Heritage Trust (NPHT) to make their internationally important archival collections relating to disability sports more accessible. Following a Wellcome Trust funded project called Spinal2Sport, which aimed to widen access to these collections, 463 boxes of unlisted archive records remained. To make these accessible, the Archives Service recruited 41 volunteers, who gave 5,000 hours of their time, to catalogue 35,000 records. These records can now be searched online for the first time."

"All of us deserve the best possible lives as we grow older, and our whole society reaps the rewards when people can age well. Our new analysis of the state of ageing in England in 2025 reveals millions more of us are living into our seventies, eighties, nineties and beyond, in good health, working for longer and supporting our communities through volunteering and caring.

But this report also highlights that this rosy, positive picture of ageing is unobtainable for many, such as those who are living in poor housing, in poverty and poor health, and who are isolated from their communities and society. The report shows the impact of regional inequalities that determine the quality of people's later life. Quite simply, where you are born in England determines how you live and how well you age." Hidden hardships: the immigration system and child poverty

New report from IPPR, which shows:

- "There are around 1.5 million children in families with migrant parents in poverty more than a third of the total number of children in relative poverty.
- Children in families with migrant parents are more likely to be in very deep poverty (under 40 per cent of median income): 21 per cent, compared to 8 per cent of other children.

These figures underline the severe and systemic disadvantages migrant families face. Potential factors which exacerbate this disadvantage include the 'no recourse to public funds' (NRPF) condition, high visa fees, and limited access to affordable childcare. Families in the asylum system face additional intersecting challenges, receiving only £49.18 per person in their household, with up to £9.50 more if someone is pregnant or if they have a child under three." BBC News report:

"Ukrainians in the UK are losing out on job opportunities and homes because of uncertainty over how long they will be allowed to stay in the country.

They were initially given the right to live and work in the UK for three years and can apply for an 18-month extension 28 days before their original visa expires. The government said this provided 'certainty and security'.

But some Ukrainians have told the BBC that employers are reluctant to hire them or landlords will not rent to them because their visa is due to expire.

One survey of 1,133 Ukrainians in Britain, external suggested 41% had lost a new job opportunity because of visa uncertainty, while 26% said their tenancy was not renewed.

Researchers from the University of Birmingham also found 22% of respondents said a job contract was not renewed, while 24% said they could not sign a new tenancy."

The data, which covers reports of physical assault, pseudo-scientific counselling, prayer as a form of healing, 'corrective rape', exorcism, community exclusion and more, indicates that these practices remain widespread.

In total, nearly a third (31 per cent) of LGBTQ+ people in the Great Britain—wide survey report that they'd experienced one or more [...] attempts to change/alter their gender identity or sexual orientation [...]"
