"As anti-DEI (diversity, equity, and inclusion) sentiment gains traction in the US, its ripple effects are being felt here in the UK – quietly and decisively. Following the election of Donald Trump overseas and a growing backlash against diversity, equity and inclusion, major corporations – including McDonald's, Meta and Amazon – have scaled back or abandoned their DEI commitments. In parallel, some UK businesses have begun to dilute, sideline, or erase their own DEI work.

What may seem like a simple shift in language, is actually an erasure of terms such as 'anti-racism', 'intersectionality', and 'inclusion' to more generic umbrella HR terms. Meanwhile, the Financial Conduct Authority's (FCA) and Prudential Regulation Authority's (PRA) scrapping of proposed diversity target due to industry pressure, is another example of institutions backtracking when racial equity work becomes politically inconvenient [...]

At BEO, we reject the idea that the continued delivery of DEI and antiracism policies are simply a corporate 'nice to have'. They are a moral, economic and strategic imperative. We unapologetically call on businesses and institutions to do more, not less to dismantle structural racism. Failure to continue to address inequity will lead to financial risk, deeper systemic inequality, and reputational harm."

"New analysis from Learning and Work Institute for the Commission for Healthier Working Lives shows that the number of people economically inactive due to ill health has risen across all UK nations and regions. But a closer look at variations in health and job outcomes across the country reveals persistent inequalities between local areas. In 2020-22, nearly 10% of the total number of people who were economically inactive due to ill health lived in only 20 local authorities (out of 372) representing 4% of the working age population.

The report takes a detailed look at these geographical variations and potential solutions, combining analysis of national data and existing research with six local area case studies. The selected case study areas were Belfast, Coventry, Newport, South Ayrshire, Westminster, and Wokingham."

This latest Briefing examines the accommodation of people seeking asylum in the UK:

"The use of contingency accommodation to house asylum seekers has increased significantly since the pandemic. At the end of Q1 2020, only 5% of asylum seekers were housed in contingency accommodation, but by 31 December 2024 over a third were staying in such facilities, mostly hotels [...]"

"The UK's asylum backlog – defined here as the total number of asylum applications awaiting an initial decision – stood at around 91,000 on 31 December 2024. That was 31% lower than the record levels reached in 2022, though still high by historical standards [...] Of those waiting for an initial decision, around 50,000 people (55%) had been waiting for more than six months.

The backlog had increased rapidly between 2019 and 2022, reaching an all-time high of 132,000 applications. It then fell significantly the following year. However, the decline in the backlog slowed considerably in 2024 in fact, it increased in the third quarter before falling again in the last three months of the year."

"The word 'smuggler' or 'gang' is deliberately designed to inspire fear. Over the last few years, the image of a migrant 'invasion', facilitated by the mysterious, ominous 'smuggler', has been manufactured to reinforce the idea that migration through criminalised routes is something to be feared.

Instead of using such demonising language, we should be examining why people are forced to turn to intermediaries in the first place. An important part of using the language of intermediaries instead of 'people smugglers' is to emphasise that criminalisation is a policy decision, as is the choice by the Government to refer to people who facilitate Channel crossings as 'people smugglers'. It is a policy decision to force people to use intermediaries to migrate to the UK by criminalising and reducing alternative, safer routes."

> "Reflecting on the last two weeks, I am sure I am not alone in feeling an enormous sense of sadness and frustration. Once again, divisive politics has won, further spreading division and giving far-right ideas legitimacy.

Prior to the local government elections, some of our groups and supporting organisations were on the receiving end of unfounded and aggressive social media posts by individuals who are now elected officials. Is this the country we want? This legitimised behaviour is what we expect to see in the countries from which people seeking sanctuary have to flee.

One thing is clear: whatever steps are taken to 'control migration', it will never go far enough for those who seek to promote hate and divide our communities. When we treat newcomers as strangers to be feared rather than neighbours to be welcomed, we become strangers to our own values of compassion and fairness."
