Digital Inclusion Innovation Fund

"The Digital Inclusion Innovation Fund is one of the First 5 actions from the *Digital Inclusion Action Plan: First Steps* to support digitally excluded people. The fund aims to support:

- innovative interventions to produce new knowledge on 'what works', building the evidence base on effective digital inclusion interventions
- best practice with the ambition to scale and replicate successful activities across England to increase digital participation

Grants of £25,000 to £500,000 are available to fund projects of different sizes."

In terms of what the funding could include:

"Applicants are encouraged to consider a range of topics relevant to digital inclusion, including but not limited to:

- **community engagement** how can digital inclusion support greater social cohesion and strengthen local communities?
- financial services are there ways to improve access to financial services and economic empowerment through digital inclusion interventions?
- **employment** how can expanding engagement with digital society help people to access and pursue employment opportunities?
- education and skills how can increasing digital inclusion support greater access to education and skills including media literacy?
- **safety and security** what interventions can support greater understanding of how to be safe and secure in a digital society?
- health and wellbeing what are the opportunities to support greater understanding of and control over personal health and wellbeing through digital inclusion?"

This is really interesting – it argues that we don't recognise the role that many young, working-class men play:

"In listening to the young men at the project launch of Birds, Bees, Bikes and Trees [see: https://baltic.art/news-and-media/birds-bikes-bees-trees/] I learned that they live their lives locally. They do not go on holidays abroad. They visit local shops and the vast majority do not own a car – they walk, cycle or take public transport.

But they are not commended for their green citizenship. Instead, they are often marked by poverty and deprivation. This view, which sees them as lacking, consigns their demographic to marginalisation. They are seen as without education and without opportunity. It also helps explain why private car ownership is seen as aspirational."

"New analysis for Age UK has found that 2.4 million (19%, nearly one in five) older people have limited use of the internet – using it less than once a month or not at all [...]

Findings for Age UK found that limited internet use is more common among older people in some groups, rising to 32% for older Black and 26% for older Asian people, 30% for older people who live alone and 22% for older women and those struggling financially."

"The Museums Association has responded to the Equality and Human Rights Commission (EHRC) Code of practice for services, public functions and associations: consultation 2025 [...]

In our response we:

- Expressed our commitment to equality, diversity, inclusion and the belief that museums should be safe and inclusive spaces for all, including trans staff and audiences
- Raised concerns that the EHRC Code of Practice focuses on exclusion rather than inclusion and asked for the Code of Practice to provide examples of how trans people can still be included in services and spaces in the context of the ruling
- Highlighted how museums are informing and enriching people's understanding of identity and belonging through the stories they tell
- Raised that it would be inappropriate, unethical and impractical for museums to ask staff, volunteers or visitors about birth sex and gatekeep who can access services, events and toilets."
